Subject: **Admission to B-Pharmacy & D-Pharmacy Courses-2025 in Government/Private Colleges/Institutions of UT of J&K: Invitation of online applications thereof.**

Notification No. 035-BOPEE of 2025 Dated 08-04-2025

Online Applications are invited from the eligible/desirous candidates who intend to appear in the Common Entrance Test for admission to B-Pharmacy & D-Pharmacy Courses for the academic session-2025 in Government / Private Colleges / Institutions of UT of J&K. The selection of the candidates to such courses shall be regulated by the J&K Board of Professional Entrance Examination Act, 2002 and the Rules and Regulations there under; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Re-organization Act, 2019, J&K Reservation Rules, 2005 as amended vide S.O. 69 dated 28-02-2020, S.O. 249 dated 23-07-2021, S.O. 277 dated 13-08-2021, S.O 176 dated 15-03-2024 read with S.O 305 dated 21-05-2025 and subject to further amendments, if any, made by the Competent Authority, from time to time and the guidelines as contained in the Electronic Information Brochure-2025.

Important Information:

1. Receipt of online application forms: w.e.f. **09-04-2025**.
2. Last date for filling the online application forms: **22-04-2025 (Midnight)**.
3. **A fee of Rs. 1000/ (Rupees one thousand only)** is to be paid online through Credit Card/Debit Card/Net Banking.
4. The e-Information Brochure can be downloaded from the BOPEE website, viz www.jkbopee.gov.in
5. The syllabus for the examination/test is available in the e-Brochure.
6. Date of Common Entrance Test: **(tentatively on 24-05-2025)**.
7. Candidates, in their interest, are advised to go through the Information Brochure before filling up the Online Application Form. The Board shall not be responsible for any act of omission or commission in filling up of the Online Application Form by the candidate(s). It is incumbent upon the candidates to go through the information contained in the e-Information Brochure and agree to the conditions contained therein.
8. The candidates are further advised to remain in touch with the BOPEE website www.jkbopee.gov.in. The Board does not undertake any responsibility for any delay caused in publication of Notices/ Notifications in the Print Media (Newspapers) as delay, if any, in such publication(s) is not within the control of the Board, notwithstanding that the Board notifies the same on its official website and forward the same for publication in the newspapers simultaneously on the date of issue of the said Notifications/Notices etc.
9. The Entrance Examination to be conducted by the Board shall be offline.

Online Application forms:

The procedure for filling up of Application Form and eligibility etc. of the candidates has been given in detail in the e-information brochure.

Submission of Online Application Forms:

The interested candidates are required to upload the following scanned original/self-attested certificates in PDF format with size from **100-200 KB** along with the Application Form: -

- (i) domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates of UT of Ladakh, ST certificate issued by the Competent Authority of Ladakh shall be treated as a Domicile Certificate),
- (ii) Qualifying marks (12th Class) certificate (where result is declared),
- (iii) Date of Birth Certificate (only Matriculation Certificate issued by the Board of School Education); and
- (iv) Valid Reserved category certificate, if any,

However, it is for the information of all the concerned that the afore-titled documents, as required for submission of the application form, shall be considered provisional and subject to change(s), if any, and may be notified by the Government subsequently.

A. Eligibility for B-Pharmacy Course:

The candidates applying for admission to the B-Pharmacy Course must fulfill the following eligibility criteria.

A candidate must:

- (i) be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, the ST certificate issued by the Competent Authority of Ladakh shall be treated as a Domicile certificate);
- (ii) be at least 17 years old on 31st December 2025.
- (iii) shall have passed the 10+2 examination conducted by the respective state/central government authorities recognized as equivalent to the 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, and Mathematics/Biology as optional subjects individually.
- (iv) Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations.
- (v) However, the candidates appearing/appeared in 10+2 (12th Class) examination 2025 can also apply, provided such candidates must produce the qualifying examination certificate at the time of admission, otherwise, their candidature shall and shall be deemed to have been cancelled *ab initio*.

B. Eligibility for B-Pharmacy (Lateral Entry) Course:

- i. be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, the ST certificate issued by the Competent authority of Ladakh shall be treated as a Domicile certificate);
- ii. has passed the D-Pharmacy Course from an institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act.

C. Eligibility for D-Pharmacy Courses:

The candidates applying for admission to the D-Pharmacy Course must fulfill the following eligibility criteria.

A candidate must:

- (i) be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, the ST certificate issued by the Competent authority of Ladakh shall be treated as a Domicile certificate);
- (ii) not have crossed the maximum age of 35 years on 31-12-2025;
- (iii) have passed 10+2 or equivalent examination from a recognized Board / University with Science subject viz Physics, Chemistry, Biology (PCB) or Physics, Chemistry and Mathematics (PCM) and English securing minimum 40% marks in aggregate for Open Merit candidates and minimum 35% for Reserve Category candidates in the qualifying examination.
- (iv) be medically fit.
- (v) However, the candidates appearing/appeared in 10+2 (12th Class) examination 2025 can also apply, provided such candidates have to produce the qualifying examination certificate at the time of admission, otherwise, their candidature shall be cancelled ***ab-intitio***.

Syllabus:

The candidates applying for the courses mentioned above at (A), (C) are advised to go through the syllabus for the Common Entrance Test referred to in the e-information brochure of B-Pharmacy and D-Pharmacy Courses available on the BOPEE website www.jkbopee.gov.in.

Note-I

Eligibility is bare minimum/provisional and shall be subject to such changes/benchmarks as may be fixed by the Competent Authority/University concerned. The Board shall, on receipt of any such communication from the authority/University concerned, notify the same, which shall govern the eligibility criteria.

Original Documents required to be submitted to the Institution at the time of Admission: -

- a) Marks certificate of the qualifying examinations (12th class marks certificate);
- b) Date of birth (Matriculation / Secondary School Certificate) from a recognized Board of School Education.
- c) Domicile Certificate for candidates belonging to UT of J&K and ST certificate as a Domicile for candidates belonging to UT of Ladakh;
- d) Category Certificate, if any;
- e) Any other document as may be required by the Institution.

Venue for Conduct of Examination:

The Common Entrance Examination shall be conducted offline at Jammu / Srinagar centres simultaneously as may be decided by the Board.

Issuance of Admit Cards and Date of Test:

Information with regard to the availability of Online Admit Cards, Venue, and Time of the Common Entrance Test will be issued separately in due course of time.

Note-II

1. The sports category candidates have to indicate their sports category on the Application Form. They are also required to submit their Sports Certificate(s) in the office of the Secretary, J&K Sports Council, for determining their sports points, which shall later be officially forwarded by the Council to the BOPEE. The BOPEE, however, shall not be responsible for the non-inclusion of any candidate on the list forwarded by the Sports Council or delay on their part for submission of sports points to the BOPEE.
2. The candidates having more than one reserved category certificate can get the benefit of only one category indicated and uploaded along with the Application Form, which in no case shall be changed afterward. The candidate whose category certificate has not been found valid upto the last date of registration for counseling, the candidature of such candidates, if selected, shall be deemed to have been canceled ab initio.
3. The CDP category candidates are advised to write their priority (01-08) in the online Application form issued by the competent authority.
4. The online submitted Application Form is purely provisional and is liable to be cancelled at any stage subject to the final verification of the documents and even at any stage, where such a document is proved to be fake/false.
5. The candidature of those candidates who may have uploaded the wrong category or submitted incorrect/wrong application form during the online process shall be liable to be rejected without any further notice to such candidates. However, they can rectify their correction(s), if any, by submitting a representation physically at the BOPEE office in Jammu/Srinagar on or before the last date fixed by the Board for filling up of online application forms.
6. Mere submission of the Application Form and appearance of the aspiring candidate in the Entrance Test shall not confer any preferential right/claim for admission upon the intending applicants, but shall be subject to the fulfillment of the eligibility criteria and the qualification prescribed for the said course.
7. The seats shall be provisionally allotted to the candidates purely based on the online information filled by the candidates (including category) during the online application form. In case the candidates have filled/uploaded the wrong category during the online application form, the seat shall be allotted accordingly, & the Board shall not be responsible for the same. Hence, the candidates are advised to rectify the mistake before the allotment of the seats.
