In the beginning, the Chairman welcomed all the members.


Item No.1: Regarding adoption of syllabus as per PCI for the current batch 2022-23:

It was unanimously resolved that the department will adopt choice based credit system, semester scheme and PCI syllabus for B. Pharm degree course in toto, and align the same with regulations devised by UGC, AICTE and University of Kashmir. Further the newly devised course structure and curriculum will be aligned with BOPEE entrance test scheme as well as CBCS scheme of the University of Kashmir. Further it was resolved that the department will undertake a rigorous exercise regarding anticipated workload of teachers in odd and even semesters and the requirement of full time contractual faculty for this purpose and submit the same to higher authorities. Further it was resolved that the department will apply for PCI approval of its M. Pharm course also. Once the new course structure and curriculum for B.



Resolved that another Departmental Committee meeting will be convened soon to finalize all modalities in this regard. ?





ADOPTION OF REVISED SYLLABUS AND COURSE STRUCTURE FOR 4 YEAR B. PHARM. DEGREE PROGRAMME

This department shifted to four-year B. Pharm. Degree Programme after 10+2 in consonance with AICTE Guidelines w.e.f academic session 2005, after getting necessary approval from AICTE in the year 2005. Syllabus and course structure devised for four-year degree programme in the year 2006 was continued till date. However, in view of the jurisdiction of Pharmacy Council of India and the purview of Pharmacy Act of 1948 getting extended to UT of J&K post abrogation of Article 370, this department is now mandated to revise the syllabus and course structure of its four-year B. Pharm. Degree programme in tune with Education Regulations 2014 of Pharmacy Council of India. This is also necessitated by the fact that from the academic session 2022-23 admission for B. Pharm. degree programme is being conducted by J&K Board of Professional Entrance Examination (BOPEE)

As such a meeting of Board of Studies of this department was convened on 17-06-2022 with a view to revise the syllabus and course structure of four-year B. Pharm. degree programme and bring it in consonance with Pharmacy Council of India Regulations. A copy of the minutes of said BOS meeting is attached herewith as *Annexure-I*, wherein it has been resolved as under:-

"After threadbare discussion it was resolved that the course curriculum and course structure devised by PCI, New Delhi vide Education Regulations, 2014 shall be adopted and got approved by the statutory bodies of the university like Academic Council. However instead of 100 days, 90 days calendar will be followed per semester. As such a copy of course curriculum and course structure for the four-year B. Pharm degree programme is hereby adopted and submitted for approval of the competent body".

As such a copy of revised syllabus and course structure duly recommended by the Board of Studies and Department Committee is submitted herewith as *Annexure-II* for necessary approval of the statutory authorities/bodies of the University.
