In the beginning, the Chairman welcomed all the members.

Item No. 1: Representation of Miss Samreen (Ph. D scholar Pharmacology) with regard to replacement of plant *Salvia Moorcroftiana* Wall. by *Primula denticulate* resulting in the change of Ph.D project title from "Evaluation of *Dipsacus inermis* Wall and *Salvia Moorcroftiana* Wall. on Oxidative Stress and Over Expression of TNF- α in Streptozotocin-Nicotinamide Induced Diabetic Nephropathy in Rats" to new proposed title "Evaluation of *Dipsacus inermis* Wall. and *Primula denticulate* on Oxidative Stress and Over Expression of TNF- α in Streptozotocin-Nicotinamide Induced Diabetic Nephropathy in Rats". The scholar could not collect the plant citing reasons that the flowering period of the plant had already passed and she had to wait for one more year.

Resolved: In order to save the time of the scholar, the DRC recommends that the request of the scholar be accepted and she be allowed to make change in the project title as reflected above.

Item 02: Representation by Miss Aneeqa Rafiquee (PhD scholar Pharmaceutical Chemistry) requesting the change in her Ph. D topic from "Design and Synthesis of Novel Artemisinin Derivatives with Potentially Improved Anticancer Properties" to new proposed topic "Phytochemical and Pharmacological Studies on Rheum webbianum Royle for its Antidiabetic Potential" and appointment of Dr. Mohammad Younis Dar (Research officer-Chemistry, RRIUM) as Co-supervisor.

The reasons cited by the scholar was that, she was not allowed to work at CSIR-CDRI Lucknow, in view of a circular issued by CSIR restricting the PhD scholars to work over there. Further, the scholar recently joined the department after availing maternity leave.


Resolved: The DRC recommends that the request of the scholar be accepted and she be allowed to work on new project as she successfully defended her synopsis on the new topic. Further, DRC also recommends the appointment of Dr. Mohammad Younis Dar (Research officer-Chemistry, RRIUM) as Co-supervisor. The case will be forwarded to concerned quarters for further necessary action in light of Ph. D guidelines.


