With reference to the subject cited above, I am directed to inform that subject cited issue was considered by 391st Executive Committee of the PCI in its meeting held on 5th March, 2023, EC decided that the larger interest of the students and to maintain the timeline for 2023-2024 academic session.

In view of above, it was decided as under -

- Regarding extension of approval for existing course
 - to extend approval for the year 2023-2024 academic session (one year) in respect of those institutions which are approved by PCI as per approved course and intake in 2022-2023.
 - the inspection will be conducted throughout the year and outcome of inspection will treated as the decision for 2024-2025 academic session.
- Regarding introduction of new course and raise in admission in the existing institutions
 - to extend the approval of existing course as approved by PCI as per approved intake in 2022-2023.
 - Regarding introduction of new course and raise in admission, inspection will be conducted if statutory documents are complete. Wherever statutory documents are not complete, seven days time be given to institutions to submit the same failing which application for introduction of new course and raise in admission be rejected.
